Before each film, for thirty minutes as the audience is finding their seats in the theater, ad slides containing all of our sponsors' logos will be shown onscreen. After the ad slides, before a captive audience, we'll show previews of upcoming films and a Bozeman Doc Series trailer, which will include clips from upcoming films as well as each sponsor's logo. The higher the sponsor level, the more prominent the placement and longer the duration of the logo in both the ad slides and sponsor trailer.
